#### DEACONESS WORK

#### REPORT No. 1.

We recommend the following changes in the Constitution:-

- 1. Re memorial asking that Par. 312 be amended by adding the words "or other Deaconess Institutions" immediately after the words "Deaconess Home," that the words "Deaconess Institutions" be sustituted for the words "Deaconess Homes."
- 2. Concurrence re memorial asking that the following be inserted in Par. 322, and numbered sec. 2: "A Deaconess Institution is a home, school, hospital or other organization, permanently established, administered by Deaconesses, or maintained for the care or education of Deaconesses, or for the promotion of the Deaconess work of the Methodist Church," and that the remaining paragraphs be numbered in harmony with this addition.
- 3. Re Par. 322, that immediately after the word "Conference," at the end of the first sentence the words, "in which there is a Deaconess Institution," be added.
- 4. Re Par 322, sec. 2, that this sentence be added: "In those Conferences where there is no Deaconess Institution the Annual Conference shall appoint a Standing Committee on Deaconess Work consisting of three members, one minister and two lay members (one man and one woman).
- 5. Re Par. 321, that the following paragraph be inserted as sec. 9: "Retirement of a Deaconess automatically severs her relation to the Deaconess Institution with which she has been connected, and should she subsequently arrange to reside in any Deaconess Institution, it is assumed of course that she will make suitable payment for room and board," non-concurrence.
- 6. Re Par. 321, that the following paragraph be inserted as sec. 10: "The Chairman of the General Board, at its annual session, shall enquire concerning each Deaconess as to her moral and religious character, her doctrinal views and teachings, and her suitability for Deaconess work. Should there be any objection, a committee composed of the Officers of the Board and the representative of the licensed Deaconesses, shall hear the case and report to the General Board which shall have the power to suspend or dismiss her."
- 7. Re Par. 319, that the words in sec. 1, "Rest and Relief" be struck out and the word "Superannuation" be inserted.
- 8. Re Par. 319, that the word "Rest" at the end of section 1, be struck out and the word "Superannuation" be inserted.

#### REPORT No. 2.

1. Re Memorial, signed by twenty-six deaconesses in the active work throughout the country, calling the attention of the General Conference to their opinion that the Deaconess work does not occupy the place of importance in the activities and religious life of the Church that it ought to, and also calling attention to the fact that while in the year 1909 seventy-one deaconesses were at work, the number has steadily decreased, till now in 1922 there are only forty-three; and whereas the Deaconesses request the General Conference to enact such legislation as shall place the Deaconess order in a position to do more effective work, or if this is impossible, to disband the order of Deaconesses; and whereas the Deaconesses express their willingness to enter any other sphere of usefulness that the Church may call them to enter;

Your Committee begs leave, first, to express the opinion that the Deaconess order has been, and may continue to be, like the Christian ministry, a most potent factor in the activities of the Church, often performing work in our large cities which our ministers find well-nigh, if not altogether, impossible; second, to express the fear that for the past few years there has developed a pronounced discontent with certain phases of the Deaconess work, which discontent may have to do, largely, with the declining number of Deaconesses in training and in actual work; third, to recommend the appointment by General Conference of a Commission to consider the management and policy of the Deaconess work, with the purpose of allaying the present discontent, and, if possible, to place the Deaconess work of our Church on a more satisfactory basis.

- 2. Re Memorial No. 3, we recommend as follows:
- (a) The endorsation of a Church-wide appeal for \$100,000.00 for the Deaconess Superannuation Fund.
- (b) Re the inclusion of Deaconess work in the proposed benefit for the Departments of the Church, no action.
- (c) That the recommended changes in the Course of Study as per the accompanying memorandum, be referred to the Committee on Course of Study.
  - (d) Withdrawn. (Page 115).

#### TENTH DAY—SIXTEENTH SESSION.

FRIDAY, October 6th, 1922.

Moved in amendment by Rev. G. N. Hazen, seconded by Rev. H. E. Thomas, That item 4 be referred back to have defined the duties of the proposed Conference Standing Committee on Deaconess Work in those Conferences where there is no Deaconess Work. The amendment was lost, and the report as a whole was adopted. (Page 330).

Moved by Rev. W. R. Young seconded by Mr. W. G. Hunt, That the report of the Committee on Church Union be received and considered.

Moved by Rev. W. R. Young, and seconded, That the debate be now adjourned. Carried.

Fund, and Sunday Schools and Young People's Societies have discovered the budget needed in order to carry out their work for the year, a joint meeting of the General Secretaries of these Departments shall be called by the General Superintendent, in order that a single statement may be issued for the Church through the Annual Conferences, and otherwise, thus bringing the total needs of all the Departments before the whole Church. This statement shall be sent to the President of each Annual Conference, whose duty it shall be to present the same to his Conference on the first day of the meeting of the Conference.

Work. W. B. Smith, That the Commission called for by the resolution of this afternoon re Budget and reorganization of Departmental work consist of seventeen members, to be elected as follows: West of Winnipeg, one minister and one lay member; east of Montreal, one minister and one lay member; and one minister and one lay member from each of the following Conferences: Bay of Quinte, Toronto, Montreal, Hamilton, and London; and further, that these elections be made by the several delegations in attendance at this Conference; also that two lay members and one minister be elected at large from the central Conferences, who shall be members of the Commission. It is also understood that the heads of Departments shall be corresponding members of the Commission, and that the General Superintendent shall be Chairman of the Commission.

Moved in amendment by Rev. S. W. Dean, seconded by Mr. A. M. Scott, That the General Conference Special Committee be the Commission. The amendment was adopted, and the resolution as amended, was adopted.

Hilliard, That the General Conference Special Committee, acting as a Special Commission to consider the question of correlating the Departments and the creating of a Budget, shall have power to call in the heads of Departments and any other persons who may furnish desired information. Carried.
